Purpose of the item

On 16 December 2020, Council resolved that a Hockey Working Group be established to identify location opportunities for a synthetic turf pitch for the Victoria Park Xavier Hockey Club. On 15 March 2022, Council resolution 51/2022 endorsed preparation of a Hockey Business Case to explore feasible options.

Now that the Business Case is near completion, and the new Australian Hockey Centre has been identified as providing an optimum solution for the Club, this item is being discussed to consider the future of the Working Group and the next phase of work to be done to assist the Club transition to its new venue.

Outcome

- A decision as to whether to wind up the Hockey Working Group following completion of the Hockey Business Case.
- A shared understanding of what the next phase of work to assist the Victoria Park Xavier Hockey Club transition to a new venue will look like.
- A shared understanding of the roles and responsibilities of both the Town and Hockey WA in supporting the Club's transition to a new venue, as part of this next phase of work.
