3.1 UFS Implementation Action Plan - Working Group Review

Purpose of the item

To present the refined summary of the UFS Implementation Action Plan review as collaboratively developed at the workshop. Also, to collaborate on the group's comments on actions that were not addressed during the workshop session due to time limitations.

Outcome

Further adjustment and refinement to the agreed group summary comments for each action of the Implementation Action Plan. Following this the final summary will be sent to members for a last chance to suggest adjustments. The final comments will eb presented to councilors during the march concept forum when a presentation on overall program progress will be delivered.

If amendments to the Implementation Action Plan are required a process will commence to seek council endorsement of the amendments.

Outcome/Actions

- The recommendations of the group were further refined and captured in the IAP review Revision D document. Below are some additional notes capturing some of the comments.
- 3.30.300 rule discussed and proposed as informing a new canopy target. Agreement to base milestones on projected canopy methodology. Questions how much it will cost over time. Justified extension and continued intensity of program as this is core business for the Town.
- Longer term actions be more ambitions, caution on not just focus on canopy given broad value of the program. Strategic connection with other Councils. More native species maintain the ambition. Group does not support slowing down over a longer term program.
- 3.30.300 not just looking at canopy but also visual site of tree, access to pocket parks, public open space close to their houses within 300m. Total overall 30% canopy.
- Factoring in dead trees into the projected methodology. Proposed not to include tree
 replacement plantings in canopy addition calculations. Potentially inaccurate as removing lots
 of dead callistemons and replacing them with large trees. Have had tree losses this summer.
- Not include tree replacements in our annual reporting and canopy measurement.
- Bushy: suggestion for target of urban ecosystems program could be to add 3000 square metres per year of urban ecosystems to align with the 3.30.300.
- Emphasis on Metronet in transport action
- Partnering with others emphasized
- Pierre to summarize 1F recommendation offline
- 1H Recommendation that Developer engage Arborist for tree impact assessment costing about \$400, education opportunity construction companies upskill. Arborist will include information on the health and structure of a tree.

- 1J Politically sensitive, would be support from a number of councilors, however would be controversial with community. Recommended approach for incentives rather than punishments.
- 1L Maybe annual award?
- Catherine Webb (DPERP) -pest and disease educator Apps: My Pest Guide Band My Weed Watcher. A lot of information is available and suggestion to create an online hub on Urban Forest webpage to collate useful sources for community education.
- 2H Resource Centre -Similar to the Creek Centre at Canning was the initial intention. Satisfaction with combined approach of Harold Hawthorn facilities and outdoor learning areas.

- A suggestion that low planting/shrubs planted in the development control area and below signage. This can be investigated at the next meeting with Mainroads.

• This maybe an opportunity for Mainroads (looking for ways to green the area). Site could be nominated for greening. Street tree planting next winter.

Action: Add to 2022 Leafy Street Program
