Urban Forest Strategy Implementation Working Group - 21 November 2022

- Trial at George Street tube stock planting 75% success rate with not water. Planting done end of July.
- Keep the tube stock alive for the long term

Q: Will we continue to use compost combining and liquid brew. A: Would have you look at the cost measure as the liquid brew is more expensive

Opportunity for the Town to capitalise on business growth for the nursery business and tie into apprenticeships, upskilling students. Economic multiply, creating jobs in the nursery area.

Healthy Catchments Program – Work with a lot of Community group lot of restoration trial and analyst on survival rates. Water holding crystals and water in on the day (water again until the soaking rains come). Emma M will get back to you with the information

Community variables - Volunteer engagement. Highlighted the need to ensure community training on how to plant the tubestock. Adopt a plant.

Poor outcome if plants are not planted with adequate soil coverage. Support liquid brewing. How the liquid brew will work with our community days.

Propagation - seed bombing, direct seeding and tissue culture as other methods of getting diversity. Include the community in the trials.
