Social Impact is defined by the Centre for Social Impact as "The net effect of an activity on a community and the well-being of individuals and families."

Why have a Social Impact Approach?

So that:

- Elected Members and C-Suite see the value of their investment in programs and projects
- Teams see the value of the work they do (increasing job satisfaction)
- Community sees the value in programming decisions

To:

- Inform decision-making based on social and economic value
- Keep community at the centre of what we do
- Ensure strategic alignment

Aims and Objectives:

A unified approach for:

- internal projects
- investment in external groups (Impact Investment)
- collaborative projects (Collective Impact)
- A simple process that teams can incorporate in their planning and evaluation
- A toolkit of resources to reduce time investment
- A communication method that tells the impact story

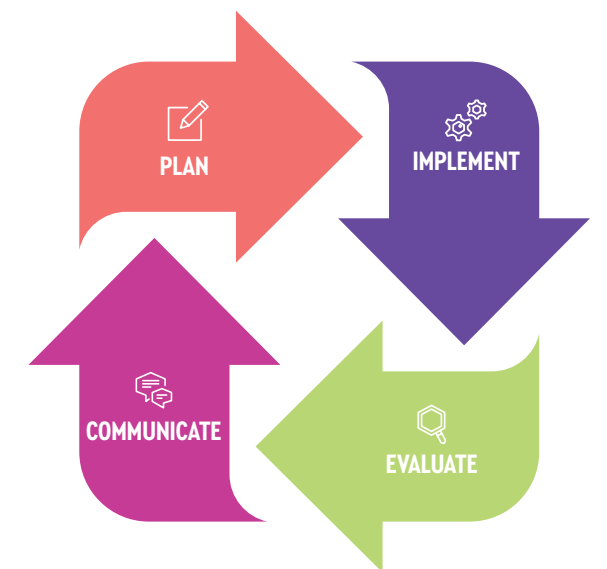

- Keep the community at the centre of all decisions

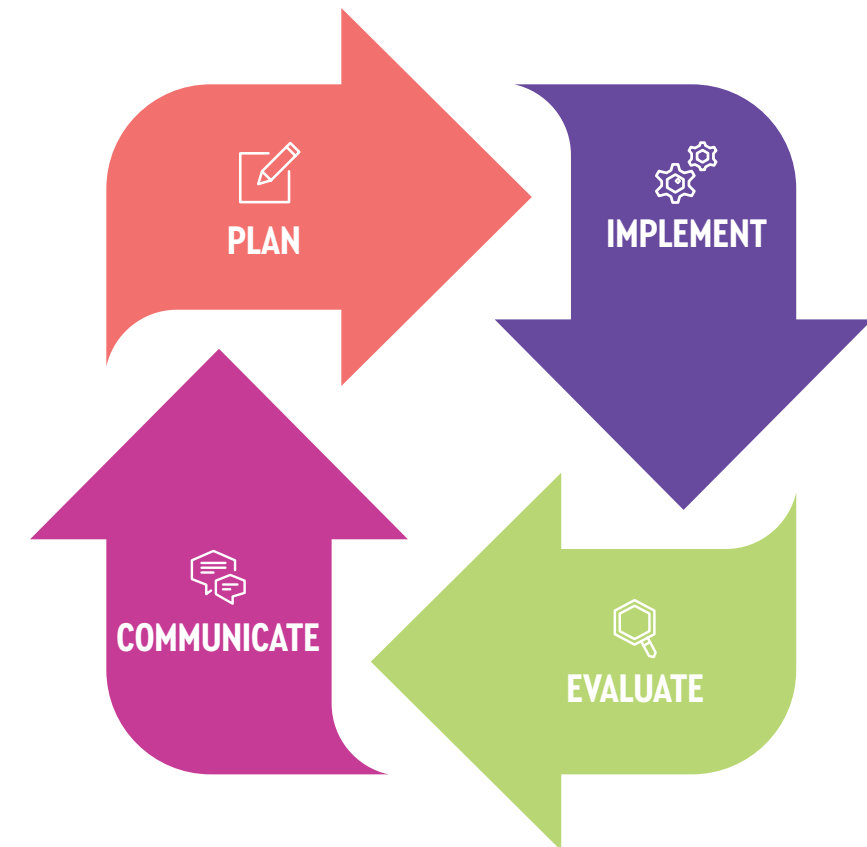

Process



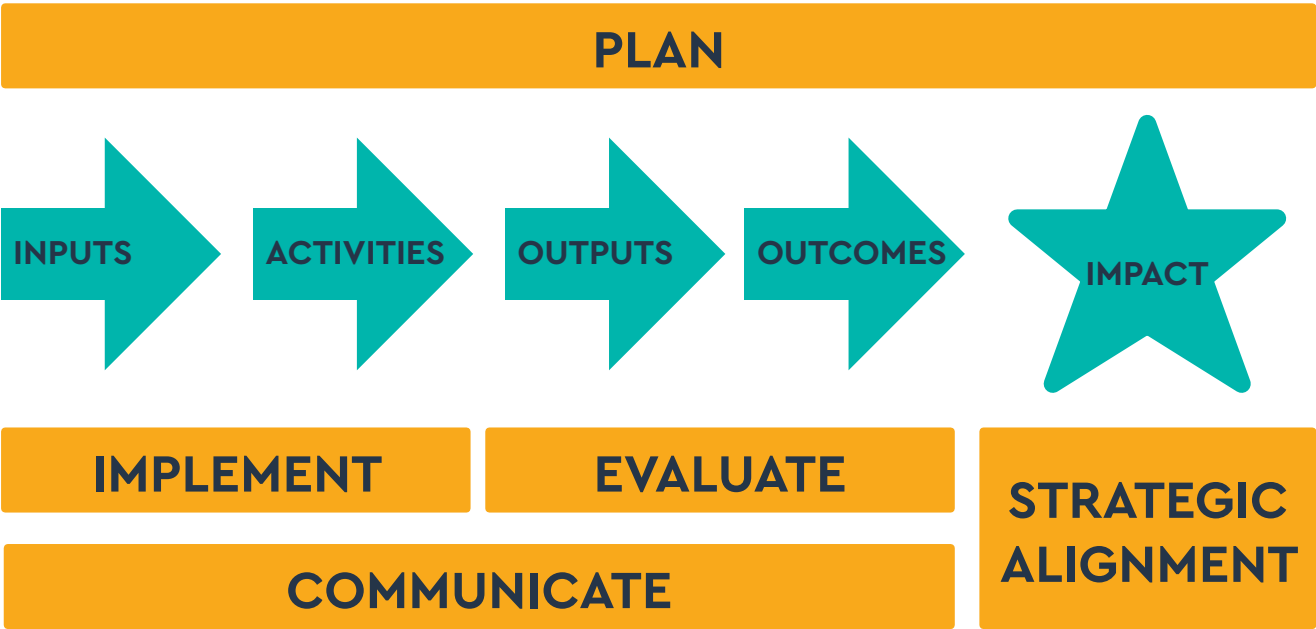
We plan using a Theory of Change a Program Logic Model and an Evaluation Plan.

We implement a range of interventions to deliver positive outcomes

We evaluate against the plan to "measure what matters".

We communicate using a storyboard and scorecards which aggregate to an annual report card for the Social Plans.

Internal Initiatives



Our Internal process framework uses the **Program Logic Model** and the Town's Social Impact Process.

By shifting the focus from outputs to outcomes and consistently evaluating for impact, we identify whether we achieved what we intended.

Our **Impact Investment framework** highlights the alignment of grant funding to our Strategic Community Priorities.

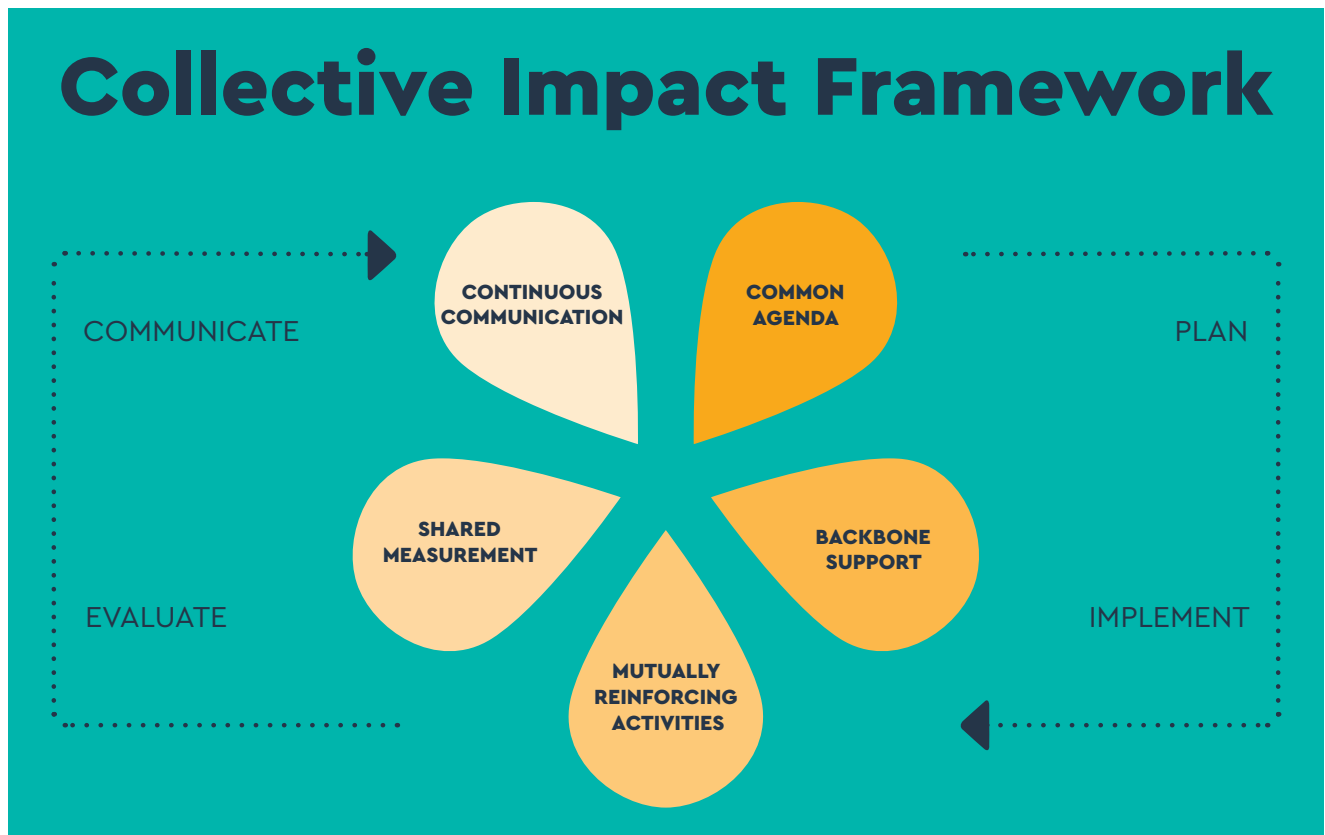
We are building the capability of funding recipients to report on the outcomes of their projects, and how these contribute to the community's priorities.
